

**GRANT OF TIMELY FINANCIAL RELIEF AND DISABILITY PENSION TO
NO 15218544N EX GNR(MACP NK) MADHUSUDAN BAGDI**

1. Refer to your Grievance Registration Number DDESW/P/2018/00134 dated 02 Aug 2018.
2. It is intimated that you were enrolled in Army on 23 Jun 2008 and invalided out from service on 12 Jul 2016 and SOS wef 13 Jul 2016 being placed on Med Cat lower than S1H1A1P1E1 and not upto prescribed military physical standard under item III(iii).
3. After due examination of your case in accordance with relevant rules and existing administrative provisions, it has been decided by the competent authority that you are not entitled for disability pension in terms of Regulations-173 of Pension Regulations for the Army 1961, Entitlement Rules for Casualty Awards to the Armed Forces Personnel-2008 since the disability TRAUMATIC PIVD C4-C5 WITH QUADRIPLEGIA (OPTD) was sustained by you during leave and the same has been regarded as NOT ATTRIBUTBLE TO MILITARY SERVICE as confirmed by MoD (Army) (Arty-10) letter No A/10026/PC-189/Arty-10(A) dt 09 Jan 18 (copy att). Therefore, you are not eligible for grant of service Element of Pension as well as Disability Element of Pension. The aforesaid facts were communicated to you vide this officer letter No 15218544N /IMB/DP-72214/pen-2 dt 21 Jul 2018 (copy att) with advice to prefer an appeal against rejection of disability pension within six months from the date of this letter, if you are not satisfied.
4. However, with regards to your invalid gratuity and DCRG a sum of Rs . 489549/- (Rupees four lakhs eighty nine thousands five hundred forty nine only) towards the payment of invalid Gratuity and DCRG have been sanctioned by the PCDA(P) Allahabad vide letter No G3/II/18232/18/Arty/C-658 dated 03 Aug 2018 (photo copy att). The said amount has been forwarded to SBI, Devlali on 20 Aug 2018 for further crediting in your account. SBI, Devlali generally takes 5-10 days for crediting the amount due to heavy workload at their end.




