Sub: Request your intervention in addressing discrepancies in the functioning of the State Environment Impact Assessment Authority (SEIAA)- Karnataka in violation of Environmental Regulations Notification, 2006 vis-à-vis, its role and way it handled the controversial Steel Flyover project in Bengaluru.

I am writing to you with reference to my Parliamentary Question No.1648- regarding violations of environmental norms in steel flyover and Peripheral Ring Road (PRR) projects in Bengaluru, answered on 31.07.2017, which states that the SIEAA-Karnataka has 'neither received any application seeking Environmental Clearance under the EIA Notification, 2006 nor any Environmental Clearance has been issued for construction of Steel Flyover in Bengaluru'.

While this response maybe true, I would like to bring to your attention glaring discrepancies in the functioning of SEIAA-Karnataka.

In 2014, the Bangalore Development Authority (BDA) proposed the construction of a 6.7 kilometre Steel Flyover from Basaveshwara Circle to Hebbal in Bengaluru without following due processes- such as voluntary disclosure of Detailed Project Report (DPR), Public Consultation, Environmental Clearances etc. Opposing this, *The Namma Bengaluru Foundation (NBF)* filed RTI applications to the BDA and SEIAA-Karnataka, and filed a Public Interest Litigation (PIL) in the Hon'ble High Court of Karnataka. Other non-government organisations also approached the National Green Tribunal (NGT)- Southern Bench, Chennai.

According to the response received from SEIAA-Karnataka to the RTI application filed by Namma Bengaluru Foundation (NBF) and the NGT Order dated March 13, 2017, the SEIAA-Karnataka through a series of communication (explained below) has clarified that the BDA did not require any environmental clearances because the project did not fall under the category of Highway:-



- a. On December 11, 2015, BDA wrote to SEIAA-Karnataka seeking opinion whether prior EC is required prior to the undertaking of the 'elevated road' project.
- b. On December 22, 2015, the SEIAA-Karnataka expressed their opinion, that it is necessary to examine whether the proposed project, falls under the definition of 'highways' and if it does not fall under highways prior EC is not necessary. SEIAA-Karnataka further advised the BDA to seek EC from the competent authority, if the proposed elevated road falls under the category of highways. The BDA was also asked to ascertain, if the road would form part of the highways because state and national highways are specifically covered under 7(f) of the schedule to Regulations 2006.
- c. On January 27, 2016, BDA wrote to BBMP seeking verification if the proposed 'elevated road' comes under the category of Highway.
- d. On February 09, 2106, BBMP responded to the BDA stating that the proposed 'elevated road' is under its jurisdiction (The BBMP did not specifically clarify if the road comes under the highway category).
- e. On February 18, 2016, based on the response received from BBMP, BDA again wrote to SEIAA-Karnataka stating "it is opined that there is no necessity of obtaining the preliminary environment discharge certificate, but sent for reference and necessary action."

It is strange that the project proponent has decided that there is no necessity for obtaining an EC as per the Regulations of 2006 and it is absurd that the SEIAA-Karnataka has failed to take action on the same.

I vociferously opposed the Steel flyover project due to its glaring environmental intrusion and it is appalling to note that throughout the series of communication between the SEIAA-Karnataka and BDA there is no reference to environmental impact due to the loss of trees. As per Paragraph 3 (7) of Regulations 2006, any decisions of the SEIAA-Karnataka must be documented in a meeting but lack of information in the communications between the SEIAA-Karnataka and BDA forces me to believe that this is opinion of the Member Secretary of the SEIAA-Karnataka. Thus, cannot be considered a decision of SEIAA-Karnataka.

Despite receiving the DPR, the SEIAA-Karnataka stated that the present project does not fall under the category of highway and is an elevated corridor with an area of 1,50,000 sq meters which was later denied by the NGT (based on information provided in the DPR) as the proposed project was an Area Development Project encompassing an area 2,13,165.9 sq meters.



The NGT has declared that the Steel Flyover Project, was environmentally intrusive and contrary to law, in as much as being in direct contradiction to the provisions of the Environment (Protection) Act, 1986 and the Environment Clearance Regulations, 2006. Additionally, the NGT had observed that the SIEAA-Karnataka had gone beyond its mandate by issuing opinion to BDA's request, which is in violation of Environmental Regulations, 2006.

In light of all the aforementioned facts, I urge you to conduct an inquiry into the functioning of SEIAA-Karnataka and take necessary action against errant officials in accordance with the law.

Violation of environmental norms in Steel flyover and PRR projects

#### 1648. SHRI RAJEEV CHANDRASEKHAR:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

(a) whether the State Environment Impact Assessment Authority (SEIAA), Karnataka has been issuing Environmental clearances and violating norms under EIA 2006 Notification dated the 14 September, 2006, as noticed in the controversial Steel Flyover and Peripheral Ring Road (PRR) projects in Bengaluru; and

(b) if so, what steps Government is taking to ensure that SEIAA honours its mandate and protect citizens and does not become a rubber stamp for State Government and builders?

#### **ANSWER**

MINISTER FOR ENVIRONMENT, FOREST AND CLIMATE CHANGE

### (DR. HARSH VARDHAN)

(a) The State Level Impact Assessment Authority (SEIAA), Karnataka, have stated that they have neither received any application seeking Environmental Clearance under the EIA Notification, 2006 nor any Environmental Clearance has been issued for construction of Steel Flyover in Bengaluru.

The SEIAA, Karnataka have considered the application submitted by the Bangalore Development Authority seeking Environmental Clearance for development of Eight Lane Peripheral Ring Road- Phase-I, connecting Tumkur Road to Hosur Road (crossing Bellary Road & Old Madras Road) under the EIA Notification, 2006. The proposal was duly considered and Environmental Clearance granted to the said project based on the recommendation of State Level Expert Appraisal Committee (SEAC) on 20.11.2014 following due diligence as per the EIA Notification, 2006 as amended from time to time.

(b) The SEIAA, Karnataka considers applications under the EIA Notification, 2006 and issues Environmental Clearances on the basis of recommendations of the SEAC in accordance with provision of law and on merit. The compliance monitoring of Environmental Clearance conditions is done against the baseline information available in the Environment Impact Assessment (EIA) report/Environmental Management Plan (EMP).
